

FY 2021 Continuum of Care (CoC) Program Competition NOFO

CoC Estimated Annual Renewal Demand Report

As stated in Section I.D of the FY 2021 CoC Program Competition NOFO, approximately \$2,656,000,000 is available in the FY 2021 CoC Program Competition, including up to \$102,000,000 available for Domestic Violence (DV) Bonus projects and up to \$77 million available for non-competitive renewal and replacement of expiring YHDP grants. HUD may add to the total amount with any available funds that have been carried over or recaptured from previous fiscal years. All requirements in the FY 2021 application process, including requirements for the entire CoC Consolidated Application and the total amount of funds available, are included in the NOFO.
